Purposes of personal data processing

Article 7. Right to Access Personal Data and Other Rights

1. The interested party user has the right to obtain confirmation of the existence or not of personal data concerning him.
2. The interested party has the right to obtain information about:
 - a) the content of personal data;
 - b) the purposes and methods of treatment;
 - c) the logic applied in case of processing with the aid of electronic instruments;
 - d) the identity of the owner, managers and the representative appointed under article 5, paragraph 2;
 - e) subjects or categories of persons to whom the data may be communicated or who can learn about them as appointed representative in the State, managers or agents.
3. The interested party has the right to obtain:
 - a) updating, rectification or, when interested, integration of data;
 - b) deletion of data processed unlawfully, including data whose retention is not necessary for the purposes for which the data were collected or subsequently processed;
 - c) certification that the operations in letters a) and b) have been notified, also as regards their contents, to those to whom the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate to the protected right.
4. The interested party has the right to oppose, in whole or in part:
 - a) for legitimate reasons the processing of his personal data, although pertinent to the purpose of collection;
 - b) the processing of his personal data for purposes of sending advertising materials or direct selling or for carrying out market surveys or commercial communication.
